Trip Policies

- 1) Trip sponsor is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$20.00 charge on any returned check.
- 4) Only members in good standing with dues currently paid in full to the Siouxland Ski & Social Club may sign up for a trip. Children under the age of 18 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the club full cost of the trip applied for, subject to the provisions for timely cancellation in item 6) below. Each trip will have its own trip deposit and payment schedule to be set up by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 6) below.
- 6) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payment the member made for the trip.
- 7) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.

Bus Trips

- 8) Smoking on buses is prohibited.
- 9) Anytime the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 10) The SS&SC will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they must do so at their own risks and assume the liabilities associated with such consumption. The member has read the trip policies and understands and agrees to be bound by them. The member further agrees that the club, its directors or committee chairmen shall bear no financial responsibility to members in event of a delayed departure or return of a trip, or for cancellation of a trip except as provided in items 6) & 7) of the trip policies, nor shall they be liable for any bodily injury, property damage or loss of personal property, or death sustained by or caused by any member on a trip. Those individuals causing property damage at the lodges, condo, busses, ski areas, etc. shall bear the full legal and financial responsibility for the damages. It is a condition of membership in the club that any individual shall be deemed to have accepted these responsibilities and limitations of liability as the consideration of joining the club and participating in club activities.
